MINUTES OF THE TOWN OF PALM BEACH TOWN CAUCUS HELD ON TUESDAY, JANUARY 3, 2017

1 A CAUCUS OF THE VOTERS OF THE TOWN OF PALM BEACH WAS HELD IN
2 THE TOWN COUNCIL CHAMBERS, AT 360 SOUTH COUNTY ROAD, PALM
3 BEACH, FLORIDA, AT 7:00 P.M. ON JANUARY 3, 2017, FOR THE PURPOSE OF
4 NOMINATING CANDIDATES FOR MAYOR AND TWO TOWN COUNCIL SEATS,
5 GROUPS ONE AND TWO.

7 The 105th Annual Town Caucus was held in the Town Council Chambers at 360 South
8 County Road, at the above named time pursuant to the call and notice thereof, which was
9 published in the Palm Beach Daily News, a newspaper in Palm Beach County, Florida,
10 on December 19, 2016, December 26, 2016, and January 2, 2017, and in el Latino
11 Semanal, a Spanish language newspaper in Palm Beach County, Florida, on December
12 16, 2016, December 23, 2016, and December 30, 2016.

14 I. CALL TO ORDER – MAYOR GAIL CONIGLIO

16 The Caucus was called to order by Mayor Gail Coniglio.

18 II. ELECTION OF CAUCUS OFFICERS

20 Mayor Coniglio advised that the first order of business of this 105th Caucus was to elect
21 Caucus Officers, consisting of a Caucus Chairperson and a Caucus Secretary. She stated
22 that, pursuant to the Town Charter and Town Code, only qualified voters may participate
23 in the Town Caucus, and that each nominator must state his or her name and street
24 address.

26 A. Caucus Chairperson

28 **On motion of Alan Golboro, 2500 S. Ocean Blvd., Apt. 1D2, the nomination of Lewis**
29 **S. Crampton, 2335 S. Ocean Blvd., #5, for Caucus Chairperson was made. Mayor**
30 **Coniglio called for further nominations. There were none. Mr. Crampton was**
31 **elected unanimously, by acclamation.**

33 Mr. Crampton assumed the office of Chairperson, and called for nominations for a
34 Caucus Secretary. Chairperson Crampton reminded all that pursuant to the Town Charter

and Code, only qualified voters of the Town were permitted to participate in this 105th Caucus. Each nominator must state his or her name and address.

B. Caucus Secretary

On motion of Allen S. Wyett, 1145 N. Lake Way, the nomination of Carol N. Wyett, 1145 N. Lake Way, for Caucus Secretary was made. There being no further nominations, Mrs. Wyett was elected unanimously, by acclamation.

III. NOMINATIONS FOR OFFICE OF MAYOR

Chairperson Crampton called for nominations for Town Mayor, the seat currently held by Gail L. Coniglio. He announced that each nominator must state the name and street address of the person being nominated, as well as his or her own name and street address.

Roberta Horwich, 2860 S. Ocean Blvd., Apt. 401, nominated Gail L. Coniglio, 1139 N. Ocean Blvd., as a candidate for Mayor.

The nomination was seconded by Richard Rene Silvin, 422 Australian Ave., and Nicholas Coniglio, 201 El Dorado Ln.

Chairperson Crampton called for further nominations, and there were none.

After a motion was made, seconded, and unanimously passed to close nominations, Chairman Crampton declared that nominations for candidates for Mayor were closed.

The Chairman then declared that Gail L. Coniglio has been duly nominated at the Town Caucus to be a candidate for the Office of Mayor, and requested that the candidate stand and state her address.

Gail L. Coniglio stood and was recognized. She stated that she is a registered voter and that her address is 1139 N. Ocean Blvd., Palm Beach, FL 33480.

IV. TOWN COUNCIL MEMBER – GROUP ONE

Chairperson Crampton called for nominations for Town Council Member-Group One, the seat currently held by Danielle H. Moore. He announced that each nominator must state the name and street address of the person being nominated, as well as his or her own name and street address.

Bruce McAllister, 224 Bahama Lane, nominated Danielle H. Moore, 277 Pendleton Ave., as a candidate for Town Council Member – Group One.

The nomination was seconded by Patricia Lebow, 272 Via Marila and Carla Termini, 2860 S. Ocean Blvd., Apt. 305.

Chairperson Crampton called for further nominations for Town Council Member – Group One, and there were none.

After a motion was made, seconded, and unanimously passed to close nominations, Chairperson Crampton declared that nominations for candidates for Town Council Member-Group One were closed.

The Chairperson then declared that Danielle H. Moore has been duly nominated at the Town Caucus to be a candidate for the Office of Town Council Member-Group One, and requested that the candidate stand and state her address.

Danielle H. Moore stood and was recognized. She stated that she is a registered voter and that her address is 277 Pendleton Ave., Palm Beach, FL 33480.

V. NOMINATIONS FOR THE OFFICE OF TOWN COUNCIL MEMBER-GROUP TWO

Chairperson Crampton called for nominations for Town Council Member-Group Two, the seat currently held by Michael J. Pucillo. He announced that each nominator must state the name and street address of the person being nominated, as well as his or her own name and street address.

Robert N. Wildrick, 220 Nightingale Trail, nominated Julie Araskog, 1490 Via Manana, as a candidate for Town Council Member-Group Two.

The nomination was seconded by Ann G. Summers, 215 El Bravo Way, Murray H. Goodman, 911 N. Ocean Blvd., Robert Davidow, 2100 S. Ocean Blvd., #401-N, and Randolph Vincent Araskog, 320 El Vedado Road.

Chairperson Crampton called for further nominations for Town Council Member-Group Two.

Nancy M. Murray, 249 Monterey Road, nominated Martin I. Klein, 1060 N. Ocean Blvd., as a candidate for Town Council Member-Group Two.

The nomination was seconded by Donald Singer, 2295 S. Ocean Blvd., #303, and Michele Beth Levbarg-Klein, 1060 N. Ocean Blvd.

After a motion was made, seconded, and unanimously passed to close nominations, Chairman Crampton declared that nominations for Town Council Member-Group Two candidates were closed.

The Chairman then declared that Julie K. Araskog and Martin I. Klein have been duly nominated at the Town Caucus to be candidates for the Office of Town Council

Member-Group Two, and requested that the candidates stand and state their addresses.

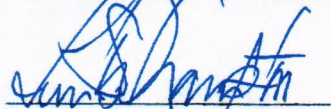
Julie Araskog stood and was recognized. She stated that she is a registered voter and that her address is 1490 Via Manana, Palm Beach, FL 33480.

Martin I. Klein stood and was recognized. He stated that he is a registered voter and that his address is 1060 N. Ocean Blvd.

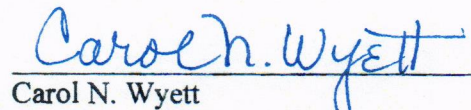

There being no further business to come before the Caucus, upon motion duly made, seconded, and carried, the Caucus meeting was adjourned at 8:03 p.m.

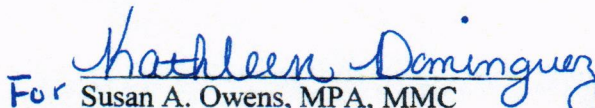


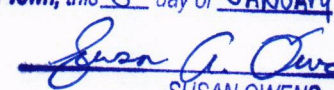
