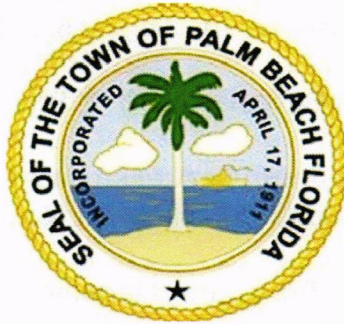




TOWN OF PALM BEACH

Minutes of the

1. **ORDINANCE NO. 020-2024:** An Ordinance Of The Town Council Of The Town Of Palm Beach, Palm Beach County, Florida; Amending The Adopted 2017 Town Of Palm Beach's Comprehensive Plan Pursuant To Chapter 163, Florida Statutes; Amending The Future Land Use Map Of The Comprehensive Plan By Changing The Future Land Use Designation For Parcels Of Land More Particularly Described In Exhibit C, From "Public", "Recreation" And "Single Family", Respectively To "Private Group Use"; Providing For Inclusion Into The Comprehensive Plan; Providing For Severability; Providing For Repeal Of Ordinances In Conflict; Providing For Codification; Providing An

Effective Date.

Director Bergman read Ordinance No. 020-2024 by title only.

Council member Araskog asked why the CI Cultural Institution was not included in Ordinance No. 020-2024. Mr. Bergman explained.

A motion was made by Council Member Araskog and seconded by Council President Pro Tem Crampton to recommend approval of Ordinance No. 020-2024 to the Town Council on the first reading. The motion was carried unanimously, 5-0.

2. ORDINANCE NO. 021-2024: An Ordinance Of The Town Council Of The Town Of Palm Beach, Palm Beach County, Florida, Amending The Amended Official Zoning Map Of The Town Of Palm Beach Updated July 26, 2022; Rezoning Parcels Of Land More Particularly Described In Exhibit B, From "R-B Low-Density Residential" District, To "CI Cultural Institution" District; Providing For Inclusion On The Zoning Map; Providing For Severability; Providing For Repeal Of Ordinances In Conflict; Providing For Codification; Providing An Effective Date.
