MINUTES OF THE PUBLIC EMPLOYEES RELATIONS COMMISSION HELD ON TUESDAY, OCTOBER 27, 2009

I. CALL TO ORDER

The meeting of the Public Employees Relations Commission was called to order on Tuesday, October 27, 2009 at 1:00 p.m., in the Emergency Operations Center, 355 S. County Road, Palm Beach, by Chairwoman Helen Hoffman.

II. ROLL CALL

Upon roll call, the following Board members were present: Chairwoman Helen Hoffman, Commissioner Peter Graves, and attending by phone, Commissioner Alan Miller.

III. FLORIDA STATE LODGE, FRATERNAL ORDER OF POLICE, INC., Petitioner, vs. THE TOWN OF PALM BEACH, Respondent, CASE NO. RC-09-001 Representation Certification Petition for Police Department Police Officers Unit

Review Tally of Ballots, Verification of Election Results and Certification of Exclusive Collective Bargaining Representative

Chairwoman Hoffman announced that the Tally of Ballots was 53 eligible voters, 47 members of the unit voted, there was one vote against participation, and 46 votes in favor of participation. There were no votes challenged. The Petitioner, the FOP, has prevailed in the election.

She stated that the role of the Commission was to certify and accept the Tally of Ballots for the Town and for the union.

Chairwoman Hoffman called for a vote on approval and acceptance of the Tally of Ballots for the Police Department Officers Unit. On roll call, the vote was unanimous.

Chairwoman Hoffman announced that the Tally of Ballots was 11 eligible voters, 9 members of the unit voted, there were no votes against participation, and 9 votes in favor of participation. There were no votes challenged. The Petitioner, the FOP, has prevailed in the election.

Chairwoman Hoffman called for a vote on approval and acceptance of the Tally of Ballots for the Police Department Sergeant's Unit. On roll call, the vote was unanimous.

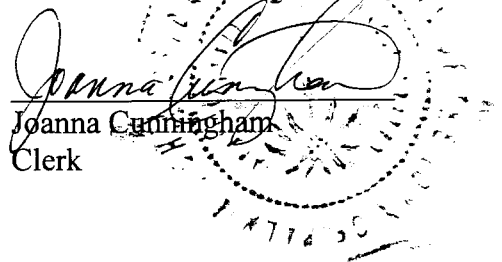
V. ANY OTHER MATTERS
